Question 1 — [FLK1 / Dispute Resolution]

A claimant (Wendy) makes a valid CPR Part 36 settlement offer to the defendant (George) of £9,500. The defendant rejects the offer. The case goes to trial, and the claimant wins, obtaining judgment of £10,925. What is the primary costs consequence under Part 36?

- A: The claimant must pay the defendant's costs on the indemnity basis.
- B: The defendant must pay the claimant's costs on the indemnity basis, plus interest on those costs, from the expiry of the relevant offer period.

Question 2 — [FLK1 / Contract Law]
