A director of Nexus Media plc (a private company limited by shares) wants to allot new shares to a new investor (Daniel) to raise capital of £5,000. The company has only one class of ordinary shares. Under the Companies Act 2006, which of the following is correct regarding the director's authority to allot these shares?
